6. SECRETARY'S REPORT

7. TREASURER'S REPORT

An update on the budget was provided.

At the Town Council Finance meeting in November it will be proposed to allocate the Neighbourhood Plan £20,000 for 2017-18.

MF has met with Claire Stewart the Deputy Town Clerk in order to start completing the £1000 grant application.

8. ANY OTHER UPDATES

 Community Centre – AM reported that the Community Centre Board meeting had just been held. The Steering Group was very concerned to hear that the proposed questionaire was due to be sent out before Christmas and would only be A5. AM had a draft version of the questionnaire but was unwilling to share it without authorisation from the board.

It was agreed that SH should write a formal letter to the Board on behalf of the steering group expressing concern about the questionnaire and requesting to see the draft before it goes to print as its results could be incorporated into the Neighbourhood Plan.

AM also reported that the Community Centre group was drawing up a list of surveys that would need to be done, had discussed a draft business plan and engaged in discussion with some potential tenants.

The Wesley Centre has now been booked by a paying customer from January on a Wednesday night. Following discussion it was agreed that from January the Steering Group would meet at 8.30pm on the third Wednesday of every month at which time the hall is available. MF to confirm with TWBC.
